



Apa yang ingin kamu ketahui tentang Hukum Perceraian?

Cerai Bagi PNS

Jika kamu berstatus sebagai Pegawai Negeri Sipil ("PNS"), kamu wajib memperoleh izin dari atasan:

1. Bagi PNS yang mengajukan gugatan perceraian, wajib memperoleh izin lebih dahulu dari pejabat.
2. Sedangkan bagi PNS yang menerima gugatan perceraian (selaku tergugat), wajib memperoleh surat keterangan lebih dahulu dari pejabat sebelum melakukan perceraian dan permintaan izin perceraian diajukan oleh penggugat kepada pejabat secara tertulis melalui saluran hierarki.
